Dears Sirs,

We hereby inform you that the Ordinary General Meeting of Shareholders of this Company, held on 9 April 2006 on second call, has adopted the resolution of distributing the dividend corresponding to the Shareholders according to the following amount:

- Amount of dividend corresponding to year 2005: 0.15 gross euros per share.
- Retention, be it the case, of a 15% on gross amount: 0.021 euros per share.
- Net Amount of dividend per share: 0.1275 euros per share.

Number of issued shares with dividend rights: 90.469.680.

The payment shall be made effective from July 4, 2006. "RBC Dexia Investor Services España, S.A." has been appointed as the paying agent entity. Thus, the payment of the dividend to the adhered entities shall be made as of the previously indicated date, after producing the relevant position certificates, at "RBC Dexia Investor Services España, S.A.", C/ Fernando el Santo 20, 28010 Madrid.

This resolution has also been notified to the Sociedad de Gestión de los Sistemas de Registro, Compensación y Liquidación de Valores, S.A., for the purposes of Royal Decree 166/1992, of February 14, on stock representation through account notes and compensation and liquidation of Stock Exchange operations.
