

Results of the voting

Below are the results of the voting on each of the Decisions taken by the Shareholders General Assembly at the meeting held on 6th April 2014:

- In Decision **One.**, a total of 6,585,017,159 valid votes were issued, amounting to 61,383,893 class A shares and 446,627,859 class B shares, representing 72.185% of the stock capital, with 5,826,409,234 votes in favor, 1,295,853 against, and 757,312,072 abstentions.
- In Decision **Two.**, a total of 6,585,017,159 valid votes were issued, amounting to 61,383,893 class A shares and 446,627,859 class B shares, representing 72.185% of the stock capital, with 5,827,154,129 votes in favor, 547,908 against, and 757,315,122 abstentions.
